

## Ep.261 | As man or woman you are NOT a person

A comment was left recently on a video I created. I thought it was worth sharing with you.

One of the most important things that you and I can do, I think, is share information and thoughts with each other so we are better able to know where we are and what is afoot in this mixed up inverted reality where up is down, left is right and backwards is forwards, to name but a few. Where we are often encouraged to shoot down any messenger and ignore the message, which can be a foolish thing to do.

In that process of gathering our thoughts and sharing I have found it so helpful to also listen with an open mind and heart and then apply my own logic and discernment to see how the information shared with me fits.

I'll read you the comment, and add some comments and few thoughts of my own for clarification. I'll put a transcript of this podcast onto the webpage for this episode - a link will be in the description. On the transcript you will notice things I have added in brown, Peter's words are in black.

If this information is new to you might I encourage you to set aside some time to do some digging. To define you own powerful questions and use your own discernment.

This is from a man called : Peter. And please note I did not say this is from a person named Peter for THINGS have names.

**Knowing** the definition to the meaning of words **is vital**, so you don't go through life babbling. For **instance**, most people don't understand the difference between being a man/woman as opposed to being a person, especially when being in court.

When God has no respect for any person as written in the King James Bible in Acts 10:34, 34: Then Peter opened his mouth, and said, of a truth, I perceive that God is no respecter of persons.

The creator gave you unalienable/immutable rights as man, then of your own free will you contract with the "state" and then don't know how to respond because of a poor education system.

You don't even know you can either be the creditor of the trust or the debtor of the trust (cestui que trust, cestui que vie Act 1666 U.K.).

TO add something here:

Interesting to note that the great fire of London, listed in wikipedia as sweeping through London from Sunday the 2nd September through Thursday the 6th of September 1666. And was, if you care to do some digging, used to start this capture of your soul, creation of the cestui que trust, your straw man, your person, convincing you that you are your legal fiction, and thus you're your enslavement. All acts apply to persons, please remember this for what comes later on inclusion.

A little more on the act - London in 1666, during the black plague and great fires of London, Parliament enacted an act behind closed doors, called Cestui Que Vie Act 1666.

The act being debated was to subrogate (meaning to substitute one thing for another) the rights of men and women, meaning all men and women were declared dead, lost at sea/beyond the sea without proof that they were, so no body, no corpse, no witnesses.

The state (London) took custody of everybody and their property into a trust. The state became the trustee/husband holding all titles to the people and property, until a living man comes back to reclaim those titles, he can also claim damages. And of course, if you don't now about this, and why would you, then you won't take any action.

When CAPITAL letters are used anywhere in a name this always refers to a legal entity/fiction, Company or Corporation no exceptions. e.g. John DOE or Doe: JANE. Fictions have no consciousness, they are dead. Perhaps this is why names on tombstones are in all capital letters?

Back to Peter's comment

So, why **does** The Creator not respect any person? well, if you don't know the definition of the meaning of the words you use, then you are just babbling.

Person (n.) Directly from the Latin persona "human being, person, personage, a part in a drama, an assumed character," originally "a mask, a false face" such as those of wood or clay covering the whole head worn by actors in later Roman theatre.

So, if you move away from the creator and follow man-made laws, they are your new God, **and THAT is** an abomination.

Why don't you all wake up, and stop **allowing this? Allowing them** to put you in a box of your own making?

If you **will just** think outside of the box you will set yourself free. **For** the box they have put you into is your own mind because they tell you what to think and how.

**Yet The** creator expects you to think for yourselves.

That's why when people are summoned to court, in the all-caps lettering, they think it's them, all because they don't know English grammar. **The summons** is written in "sign language" and not English, an irrefutable truth. You will not find anything about it in the "Oxford manual style of English" but the "maxim in law" in Latin "Expressio unius est exclusio alterius, which translates into English as "The expression of one thing is the exclusion of the other" **I'll add here that is something that you might want to etch into your mind.**

**Here is one reason that is so important for you to know.** If the word man/woman is not included in the definition of the word "person" then it means it is excluded. So, you can't walk in their court **as man/woman** when you answer for the legal fiction, **your person**, because you have no standing/ right of the audience, as they only want you to act **as the person, the legal fiction**, so they can access your trust account and get paid. **And I shall add here this is why, in court they ask you to state your name for the record.**

If you open **the** summons, it is like opening the ledger of that account.

I said that all-caps lettering is "sign language," as it tells us in the "Chicago manual style of English," on pages 664, 665, and 666

664, A.S.L.(American sign language) the language of the deaf and mute to communicate.

665, The language of the illiterate who cannot read instructions, so you can give them directions by using signs, arrows, symbols, pictures, etc.

666, The language of the corporation, by becoming a corporate person. **As a side note here - corporation = corpse-oration - a dead thing speaking).**

The fix is a long time in the making **.The fallen one. Time** is short, you are being tested.

The power of letters as in words is very important, but only if you understand the definitions of the meaning of them. Why do police say I'm not going to argue? it's because they have no indemnity against harming a man/woman, likewise, why would you argue with an actor (person) who's just playing their role and getting paid for it? **It is** madness.

At this point I thanked him for the comment and asked if I could use the content to make a mini podcast. His response follows:

Yes. As you can see my grammar isn't perfect, because of my hearing all my life, and I always thought it was to my disadvantage, but as I get older I always wondered why am I seeing or hearing things differently from most other people. Now I know, it's a Godsend. He using people in a whole variety of ways, so if you understand what I have written, I can add to it.

The way the legal system works and dates back to.

Ask yourself do you really want justice?

Most people would say "yes, of course, I demand justice"

I would say "be careful what you wish **for**, by demanding justice you might just get it, not realising what exactly that, justice is or means"

The first Roman Emperor was Augustus (27 B.C.-14 A.D.) who worshipped the goddess Justitia, who mimicked the Greek goddess Dike (**we know what that is a euphemism for**), and that is why the goddess Justitia was put alongside the goddess Prudentia.

When Augustus died, his son Tiberius built Temples for her. Is this just coincidental that it was at the time of the Messiah, as foretold in the scriptures?

Do the Temples exist today?

The British Empire covered 25% of the land mass leaving behind, Its language and legal system.

If you were to enter one of those courts you would see someone in a robe and a wig presiding over it, sitting there in place of Lady justice. A man impersonating a woman, and not sitting there as a wise sage, like Samuel, as in the "Book of Samuel".

So, who is/was lady justice if not the goddess Justitia, an abomination replacing "The Father of creation," replacing the Father who's a man with a woman who clearly is not real/ living, not only a woman but worst a false deity, made of stone.

It is done to take you away from the Father and his laws to be replaced with a false deity and her legal system which requires consent, so the system will tell you. **Yet this** doesn't stop the system from pulling you in by the police.

When you are in the legal system you can guarantee you are there to answer for the corporate person you say is you, without understanding you are not answering for the man/woman as a man/woman. Why? because they (**the courts, the police and so on**) didn't create **the man or woman and** so can never allow **you (as the man or woman)** to go on the record and that presiding judge allows what he wants and not what you say at your first hearing. That's to see if you are going to conform to what they need. So they can access your "cestui que trust (cestui que vie act 1666)".

You should never answer for legal fiction, as soon as you do by getting a solicitor, they will recommend a barrister, and they will simply say what your argument is. **I'll add here the solicitor or barrister re-present your person, thus you are not presenting yourself as man or woman.**

Well, you should never argue unless you are arguing with another man/woman. **I will add here that asking ( AS KING) questions is the answer. Questions are critical. Questions will reveal the truth, and truth must come out of the mouths of others, out of witnesses. Also, when you "swear" to tell the truth, the whole truth and nothing but the truth, so help you God, are you not then confirming yourself as a liar? Be careful now, if you say no, then tripped yourself up and missed the trickery.... No one can know THE truth, you can only know YOUR truth, so if you swear to tell THE truth then are you not lying?**

When the police will say I'm not going to argue with you, they can't **argue** because they are a person acting, and you are **a** man, and that's different jurisdictions. **So it is** a mixed war. But once you show them government identification they have authority over you, with your consent and they will keep you talking **until** they get jurisdiction. **It is how they are trained. Asking you for your "NAME" and date of birth (we have not covered this here, but your birth certificate, a maritime phrase since as a boy or girl you were born, you are not a vessel and were not birthed. Your birth-ing certificate refers to the creation of your strawman, your legal fiction, your person, after you were born and your parent were duped, tricked, harassed, conned into giving you any to the state and into the slave system. Once they have jurisdiction, after all they will offer free of charge a duty solicitor. They charge that to your cestui que trust, and they give you nothing for free, even if you don't know about the trust. That's why you are CHARGED with a crime.**

In the cestui que vie trust you **are** a creditor as the man/woman or debtor as the person, you have free will to choose. **You might want to look deeper into trustees, and beneficiaries and who is what in the court room.**

But when you are sent a summons (**which is an invitation to the person to a business meeting**), it will never have your name first, never and if you like me send them back by covering up the window and return it back, normally it will have a return address for them to do so, and they will try three times just as in the denial of Peter when the Messiah said in Matthew 26:69-75 " and peter remembered Jesus words, which said to him, before the rooster crows three-time this night you will deny ever knowing me.

if you do that, they will get a police officer to serve you three times, then if you send them back will arrest you, but people never ask to see the summons. Why **should they?** there isn't one and if there was it will be in the legal fiction not conforming to correct English grammar so is saying nothing, unless you give it life to exist, all because you don't know correct English grammar, or were never taught correctly by a poor education.

The police will say it's in the court and they have it, **yet** they haven't even got a copy of it. A summons is supposed to be under oath, well that can't be done for a person that is the corporate name written down on paper, and you cannot arrest black ink writing on a piece of paper unless some fool answers to it.

**The education system is a fundamental part of this hoax, this bait and switch. Which is an intentional part of their indoctrination system. They own and control the education system but you pay for it. It is a prudent thing to consider that everything you have been taught in this corrupt and inverted world is a lie, and that by asking your own questions and making your own lines of enquiry, by utilising your discernment and logical analysis and reasoning, you will be able to learn how things really work.**

People are put under pressure for a whole variety of reasons and concede, and concede jurisdiction. **Whoever leaves the battlefield first, loses by default. So, you would do well tolerant how to stand your ground.**

They are using your own mind against you. If someone (**a man or woman**) is not giving their word that you have done them wrong, it's nothing but fiction - a yarn/story/tale. **Men and women write affidavits of truth and these can only be rebutted point for point by affidavits of truth other men and women. Persons cannot respond. Persons and other fictions can only make statements.**

Revelations 2:10 Fear none of those things which thou shall suffer: behold, the devil shall cast some of you into prison, that ye may be tried: and ye shall have tribulation ten days: be faithful unto death, and I will give thee a crown of life.

### **Part 3**

I would say to anyone knowledge is power.

Check and research what anyone tells. always live "truth," and never seek justice when you know where the root of the words we use come from. Most people speak without thinking, at times we

speak differently to different people for a whole variety of reasons, for an instant, a baby, small child, teenager, people we know, don't know, a school friend you haven't seen since school, but most important of all be aware of people who are acting ( a person,) especially when they could or will misconstrued what you are saying to there advantage because they will use the different dictionaries (English, etymology, law, etc.)

**Persons** who do this for profit, especially the police, courts, C.P.S. (Crown Prosecution Service, and any government corporation or affiliated) are as bad or I would say worse than a thief because they must be without the Lord in their hearts.

This is why we should live with and in, truth at all times and never deceive anyone. It is strange how we live with good intent, and those who are supposed to serve us will take advantage. **Indeed, those who supposedly serve us are not supposed to tell us what to do, by that very errant behaviour they are demonstrating they do not serve us, instead they serve another master. Watch carefully what people acting as persons actually do, not just listen to what they say.**

Yet, the Messiah said, the greatest amongst you should be your greatest servant. If people falter, they should be helped in any way possible, as we are not perfect, as we exist in this corrupt world with the weak falling under the spell of the fallen one who challenged the creator.

There's a word I just used "spell," used as a noun, the term "spell," is generally used for magical procedures which cause harm or force people to do something against their will. In general terms, the belief underlying the use of spells is that the wish that they embody will be fulfilled, regardless of its goodness or badness, so long as the formula has been correctly pronounced.

Broadly speaking, then, spells and prayer, like magic and religion to which they severally belong, can be distinguished by the nature of the intended purpose.

**Have you ever wondered then, why it is that we are taught spelling and how to spell at such an early age?**

Another thing I was going to tell you about is most people don't realise everything is a contract without realising it is true, especially when they sign a document without reserving their rights. in other words they don't know the difference between a signature and an autograph. Well, signature, as " sign," at the start of it, so that tells me it is not in English, it is "sign language", written as a brush mark/scribble. Whereas, an autograph is written in English, as I will show you, if your name was John Paul Smith, the correct way would be to do it this way,

**:John-Paul: Smith. Bene, "without prejudice"**

Colon before and after your given names that divide a sentence, along with a hyphen. Then the trust name is not a surname.

Bene, an abbreviation of the word beneficiary.

"Without prejudice," in law without detriment to any existing right or claim.

If you are a Christian, to be in the "Book of life," you should know your own name and it will never be written in any other format that was made by a government, that would be an abomination. Just like legal and law, that would be a mixed war and there's only one truth.

it is all in the words. just look at legalese words, evidence, surname, etc  
Evidence (n.) c. 1300, " appearance from which inferences may be drawn".  
So, it depends on who controls the narrative, and legal persons, like judges, C.P.S., and barristers are word smiths of the different dictionaries they use, if you don't know what dictionary they are using and in what contexts, using what synonym they are using and the meaning of that word, and so on again with that word, etc.

I will add here: if you are writing your own agreements, and you should (note agreements are between men and women, contracts are between persons, fictions) you would do well to include your own dictionary of words so there can be no confusion.

Sur- word-forming element meaning "over, above, beyond in addition", especially in words from Anglo-French and Old French.

Let's take a look at the language of France, as many local languages are or were spoken there in the past, and with different dialects.

By the ordinance of Villers-Cotterets in 1539 King Francis the first, made French the official language of administration and court proceedings in France, which ousted Latin, which had been used early, and is a romances language (meaning that it descended primarily from Vulgar Latin) that specifically is classified under the Galo-romance language.

France (Gaul) had been invaded, in the 3rd century by German tribes and the most important group are the Franks.

Well, different parts of France spoke different languages, french was encouraged to be more widely taught and spoken until the 1880s, then it wasn't the national language of France until under the constitution of France, and French has been the official language of the Republic since 1992" although the ordinance of Villers-Cotterets made it mandatory for legal documents in 1539.

So, if you control the language, you control the country, just like the British with their empire, which covered 25% of the land mass.

The countries still use English and their legal system until this day.

And, that's why even though we have a direct root in Latin, a lot come through French words that are rooted in Latin.

All our much older words gathered from other sources have been deleted and eradicated as if they never existed from the books just as French has taken over France, with children not speaking what I would call their native language.

Just look at the Welsh language only 20% of the population speak it, and then it indicated that 54% of Welsh speakers aged three or older speak Welsh daily, 17% speak Welsh weekly, 24% speak Welsh less often and 5% never speak Welsh, out of the 20% who speak it.

It is most important to know who and when you are speaking to people from a government-affiliated that you are NOT condemning yourself by misconstruing or its best to keep your mouth shut, especially with the police, as it will always be used against you, and never for you. AFTER ALL why would they? They are a commercial business, trading for a profit, a business like any other corporation, they are after your money.
