NOTICE OF CLARIFICATION OF SUPPORTING DOCUMENTATION

RE: YOUR PASSPORT REFERENCE xxxxxxxxxx

Dear

Thank you for your recent email, copy enclosed which states and asks for "an original full birth or adoption certificate for xxxxxx issued by the relevant authority. This must show their parents' or adoptive parents names. We can't accept photocopied documents..."

This has already been sent to you on xxxxxx via Royal Mail recorded delivery, tracking number VE768122409GB. Proof of delivery and signature enclosed along with an email receipt from yourself confirming you have received my documents.

I remind you that an Affidavit of Birth is a Birth Certificate and also shows the mother and fathers names as required.

An Affidavit of Birth, signed and notarised, is a legal document that can be used to verify the facts surrounding an individual's birth, including birth date, location, and the name of the mother and father.

As we have superior guardianship rights over our children, we are the authority.

The Affidavit of Birth previously sent to you is the original document and not a certified copy.

I take this opportunity to note that there is a typo of the name on the application. To clarify and as per all documentations sent previously including the original and notarised Affidavit of Birth the name is spelt as follows:

Please kindly update your system as the email updates show the name misspelt.

I remind you and again hereby declare that the following is a verified plain statement of the facts as we perceive them.

1. We have been granted irrevocable superior guardianship rights over our children by the Creator of the Universe.

2. We have accepted irrevocable Power of Attorney over our children's well-being and property until the eighteenth anniversary of their birth.

3. An Affidavit of Birth is a legal document

With the above clarified I trust this provides the HM Passport Office with all the necessary information to determine the unequivocal eligibility of our baby for a United Kingdom Passport: the name of the applicant; details and evidence of the place and date of her birth and evidence of the UK citizenship of the mother and father in the form of an Affidavit of Birth, a legal document.

I look forward to receiving the Passport along with all original documentation previously sent returned securely and by recorded mail. As mentioned previously I have paid the additional fee to make sure my documents are returned in good order.
