Thank you for your letter which was attached via email and received yesterday. We appreciate your reply and for acknowledging the corrected spelling of xxxxxxxx name. Thank you.

Please acknowledge and let it be known by all concerned, interested and affected parties that:

We have been granted irrevocable superior guardianship rights over our children by the Creator of the Universe.

We have accepted irrevocable Power of Attorney over our children's well-being and property until the eighteenth anniversary of their birth.

For and on behalf of our children, we have settled their entire legal estate into a private trust which is administered for their maximum benefit.

The property settled into said private trust includes without limitation, any and all information pertaining to the existence of our children, strictly precluding the disclosure of the details of their birth to the Registrar or any other individual, organization or legal entity.

Our lawfully declared superior guardianship rights cannot be superseded by government legislation.

- 2) Do you deny or dispute that a signed and notarised Affidavit of Birth is a legal document that can be used to verify the facts surrounding an individual's birth, including birth date, location, and the name of the mother and father?
- 3) Are you aware a notarized Affidavit of Birth is a legal document and official substitute should a Birth Certificate provided by the registrar not exist or be available?

The above demonstrates, as well as all the previous documentation sent, that we, the natural mother and father hold parental responsibility and can consent to the passport application.

We look forward to our application proceeding and receiving the passport without further delays.
